# The Foundation and The Endowment Fund What's the Difference?

#### The Foundation

The Lakewood Masonic Foundation is a brand new entity incorporated in October 2003 to offer members of the Lakewood Masonic Family and other friends of the Lakewood Masonic Temple an opportunity to provide financial support with potential tax advantages to the donor. Gifts to the Foundation are deductible for federal income tax and federal estate tax purposes to the extent permitted by law.

The Foundation's purposes are to raise and provide funds for historic preservation, charity and education. Restoration and preservation of the Lakewood Masonic Temple is currently the primary focus of the Foundation. Funds raised for this purpose will be granted to the Lakewood Masonic Temple Company for qualified projects which assist in restoring and maintaining the building in its original historic condition. These grants will supplement the Temple Company's traditional revenue streams from owner assessments, rentals and endowment income.

While it is easy to visualize many of the Temple's special features such as leaded glass windows and Lodge Room murals, other aspects of the building are essential to the Temple's survival but are unseen. For example, the walls and floors are full of steam pipes, water pipes, drains and electrical conduits, nearly all of which are approaching 90 years old. These systems are expensive to repair and improve, but they are elements vitally necessary to maintaining and restoring the Temple as an historic building.

The Foundation will also manage scholarship and philanthropic funds for individuals or organizations wishing to donate for these purposes.

#### The Endowment Fund

The Endowment Fund was started in 1986. It was then, is now, and will continue to be a part of the Lakewood Masonic Temple Company. As such, gifts to the Endowment Fund are not deductible for federal tax purposes. Donors who wish to support building maintenance and improvements but who are not concerned with the tax advantages of gifts to the Foundation should consider instead donating to the Endowment Fund.

The purpose of this Fund is more specific; namely, to "help with the maintenance, rehabilitation, reconstruction or renovation of real property owned by the Lakewood Masonic Temple Company." Moreover, this Fund was established and operates with the promise that only the income is spent and that the Fund's principal can only be used for emergency reasons and by an affirmative vote of 3/4 of the LMTC Board of Trustees.

### How Can I Give to the Foundation?

The easiest way to give is to donate cash by making a check payable to the Lakewood Masonic Foundation and mailing it to the Foundation at 15300 Detroit Avenue, Lakewood, Ohio 44107-3828. There is a form printed on page 12 that you can use for this purpose.

Another way to give is by donating securities. There may be a tax advantage when directly donating appreciated securities since you may be able to avoid paying capital gains tax on the donated securities—in contrast to selling the securities and then using the proceeds to making a cash donation. There is no tax advantage in donating depreciated securities, so it is usually wiser to sell the securities, take the capital loss against your income taxes, and then give the proceeds to the Foundation.

You can also give by naming the Lakewood Masonic Foundation as a beneficiary of a life insurance policy, an IRA, or your estate. Especially in matters such as these, you are best advised to discuss your intentions with an attorney and a tax accountant.

Gifts to the Foundation are deductible for federal income tax and/or federal estate tax purposes to the extent permitted by law.

### **Temple Company News**

Utilities. Natural gas, electricity, water, sewer, telephone. We can't live without them. Do you cringe every time you find one of these bills in your mailbox? Imagine the costs of operating a building as large as our Temple!

For a number of years your Temple Company has focused on reducing operating costs by improving operating efficiencies. Take, for example, our heating costs. Our annual gas bill is our largest single utility expense. After one of the colder winters of the mid-1990's, we installed a setback thermostat to automatically turn down the heat overnight and on weekends when the building is not in use. We estimate that we reduced our gas usage by 15% in the first year; and, as we fine-tuned our programming, our savings grew to 20%. We achieved additional savings after the installation of our new high efficiency boiler in 2001, and in the first two full seasons thereafter we saved an additional 15%. These two improvements have enabled us to heat our building using 1/3 less gas than our prior experience. This translates into savings of thousands of dollars each year.

Most operating cost savings such as these can only be achieved with an up-front investment. Your contributions to either the Lakewood Masonic Temple Endowment Fund or to the new Lakewood Masonic Foundation provide urgently needed funds to maintain and improve our historic Temple as an affordable home for our Lakewood Masonic Family and other community groups.

#### Master's Message

Greetings Brethren:

This year seems to be going by pretty fast; Inspection is over along with the Grand Master's Reception. By the time you read this we will be back from our annual trip to Dominion Lodge in Windsor, Ontario. And before you know it, it will be time for our picnic on July 11.

We all keep busy these days and have so much to do that we tend to forego things that we really enjoy. Many of use have to use PDAs to schedule our days and weeks ahead of time. So the next time you're working on your schedule, set aside some time to attend your lodge; and don't forget the picnic.

#### Why Is Masonry So "Secretive?"

It really isn't "secretive," although it sometimes has that reputation. Masons certainly don't make a secret of the fact that they are members of the fraternity. We wear rings, lapel pins, and tie clasps with Masonic emblems like the Square and Compasses, the best known of Masonic signs which, logically, recall the fraternity's early symbolic roots in stonemasonry. Masonic buildings are clearly marked, and are usually listed in the phone book. Lodge activities are not secret—picnics and other events are even listed in the newspapers, especially in smaller towns. Many lodges have answering machines which give the upcoming lodge activities. But there are some Masonic secrets, and they fall into two categories.

The first are the ways in which a man can identify himself as a Mason grips and passwords. We keep those private for obvious reasons. It is not at all unknown for unscrupulous people to try to pass themselves off as Masons in order to get assistance under false pretenses.

The second group is harder to describe, but they are the ones Masons usually mean if we talk about "Masonic secrets." They are secrets because they literally can't be talked about, can't be put into words. They are the changes that happen to a man when he really accepts responsibility for his own life and, at the same time, truly decides that his real happiness is in helping others.

It's a wonderful feeling, but it's something you simply can't explain to another person. That's why we sometimes say that Masonic secrets cannot (rather than "may not") be told. Try telling someone exactly what you feel when you see a beautiful sunset, or when you hear music, like the national anthem, which suddenly stirs old memories, and you'll understand what we mean.

"Secret societies" became very popular in America in the late 1800s and early 1900s. There were literally hundreds of them, and most people belonged to two or three. Many of them were modeled on Masonry, and made a great point of having many "secrets." Freemasonry got ranked with them. But if Masonry is a secret society, it's the worst-kept secret in the world.

#### Master's Message

Greetings to all Masons!!!

Being as this edition of *The Foundation Light* covers two months of Masonic darkness, the months of July and August, we thought we would bring you some Masonic Light in the form of an explanation of what "Council R. & S. M." means and how it relates to the entire Masonic degree structure.

Council obviously means that our group is called a Council of Masons. We meet in a place called the council chamber, such as Chapters, Lodges and Commanderies designate what their group is called because they meet in chapters or lodges, etc. The R. & S. M. refer to Royal and Select Masons and comes from the titles of two of the degrees that are conferred in a Council of Royal and Select Masons.

The Royal Master Degree. This is the first of the Council degrees. It is conferred in a place known as the council chamber, which represents the private apartment of King Solomon's Temple, where he and his two associates met for consultation and deliberation during the construction of the Temple. The drama portrayed in it sheds additional light on both the Master Mason and Royal Arch Degrees. It and the next degree are essential to a clear understanding of the events of one section of the Royal Arch.

The Select Master Degree. In the Select Master's degree, which is the second of the Council, the place of meeting represents a "Secret Vault" or crypt beneath the Temple. The historical object of the degree is to commemorate the deposits of an important secret or treasure which, after the preliminary preparations, is said to have been made by our three Grand Masters.

The Super Excellent Master Degree. This degree was not originally a part of the Cryptic system and is not in all jurisdictions. It is required in Ohio. It has one of the best written rituals in Masonry. It deals with incidents in the reign of King Nebuchadnezzar when Zedekiah, the last King of Judah, was conquered and carried captive to Babylon. It enlarges upon the section of the Royal Arch having to do with the capture of Jerusalem by the Babylonian King and teaches in most dramatic fashion the lesson of fidelity.

I think it safe to assume that every Mason knows the orders of degrees and rites as they are conferred in the United States today. Lodge, Chapter, Council and Commandery. While our country was being formed, Thomas Smith Webb, America's greatest ritualist, rearranged the degrees that came from England in a series of Rites which make up the York Rite as we know it today. It was an attempt to preserve the Masonic ritual and to protect the beautiful and impressive lessons and truths that we know today. It is, however, interesting to view the order of occurrence of the events which they portray, their connection and the part each plays in explaining the others and in unfolding the Masonic story:

- 1. the portions of the Royal Arch antedating the building of the temple (Chapter)
- 2. the Entered Apprentice Degree (Lodge)
